## It Will All Work Out

Nothing can prepare a parent to lose a child, whether it occurs in infancy, childhood, or adulthood. It's not supposed to happen in this order. Chris Durbin lost her daughter, Nicole (age 34), during the early phases of the pandemic in New York City in 2020. This is Nicole's story.

Nicole was an inveterate overcomer. After graduating from Harrison High School, she headed east to pursue her undergraduate degree in diplomacy and international relations at Seton Hall on a full scholarship. She loved the Big Apple and was accepted into the New York City Teaching Fellows program, hoping to teach in public schools while pursuing a Master's Degree in Education. The economic crash of 2008 dashed her dreams due to teachers postponing their retirements, thus causing a lack of open positions.

No job, no problem. Nicole was an optimist and true believer that "it will all work out." She found employment as a copywriter for a small software company and was trained in a new field, UX Design, which eventually landed her jobs at Amazon and Google. Each step climbing the career ladder was fraught with stumbles. As is common in tech industries, jobs appeared and

disappeared, leaving Nicole out of work for months in search of new employment. She judiciously used the time off and severance pay to explore the world. She traveled to Italy, Mexico, Cuba, Puerto Rico, Japan,

Cambodia, Thailand, London, and Hawaii.

Nicole's love of life exhibited itself in her bubbly personality, her pink bubble gum-colored hair, and her wide circle of friends. When she was suddenly taken from this world, it caused shock, grief, and disorientation for all who loved her. Chris began the arduous task of sorting out her daughter's life from what remained in her Brooklyn apartment. She discovered that Nicole was financially savvy and passionate about her community by supporting the arts and women who were victims of domestic violence.

When Chris consulted her attorney about ways to honor Nicole's memory, she suggested setting up an endowment at The Community Foundation. Chris found the process of establishing a donor-advised fund to be simple and straightforward. Although Chris is a social worker, this was her first experience interfacing with The Foundation and its breadth of impact on the nonprofit organizations and their patrons in our community. Chris also became a member of the Legacy Society and 100+ Women Who Care. She feels

like she is keeping Nicole's bright spirit alive through the good works of the Nicole Ahl Durbin Endowment and finds comfort in the lasting effects it will produce for years to come.

The Eberle Series provides educational and networking opportunities for local nonprofits and their board members.

All sessions will take place at the Lafayette Country Club from 11 am - 2 pm with lunch provided. The cost will be \$30 per session or \$150 for the full series.

Also new in 2025 is an opportunity for current/incoming board chairpersons to attend a Board Chair Bootcamp with their executive director/CEO. In the bootcamp, participants will learn leading strategies to thrive in the Board Chair role, with topics including: preparing for and chairing effective Board and Executive Committee meetings; supporting the chief executive; and managing Board dynamics. These sessions will take place on January 16 and May 22 at the Lafayette Country Club from 10 am – 12 pm and will require separate registration of \$30 per person. #### **FUNDRAISING TRAINING**

The Community Foundation of Greater Lafayette is pleased to offer area nonprofit organizations the opportunity to participate in specialized fundraising training beginning in 2025. The Foundation has partnered with the The Fund Raising School at the Indiana University Lilly Family School of Philanthropy to bring their world-class fundraising courses to Lafayette. Participants will have the opportunity to earn their Certificate in Fundraising Management after completing 4 courses. The sessions will be from 8 am - 5 pm on the dates listed below and will take place at the Lafayette Country Club with lunch provided. These courses are eligible for nonprofit organizations serving the Greater Lafayette area and are looking to strengthen their fundraising efforts. Preference for attendees is given to organizations with 5 or fewer development staff.

Typically, these courses cost over \$1,100 each, but The Foundation is offering them for a drastically reduced rate.

## **Fueling Opportunity**

Cars for Keeps is a nonprofit organization that serves the Greater Lafayette community by providing lease-to-own vehicles for those in need of reliable transportation. They also work closely with Homestead Resources to provide clients with financial assistance classes and quarterly budget reviews to increase their stability, freedom, and potential for success. The affordability of the recipient and the term of the lease are what establish the budget that Cars for Keeps uses at wholesale auction to purchase a vehicle that meets the needs of the recipient. Unlike traditional vehicle leases, there are no payoff balances or mileage penalties, upon completion of the lease the title is simply turned over to the recipient, and they own the vehicle.

This summer, Cars for Keeps was awarded a grant for a new laptop to maintain their website, monitor budgets and invoicing, and perform day-to-day operations. Executive Director, Cory Shively said, "I am so grateful for the flexibility and portability of this

new laptop. It has enough power to use the graphics

programs, to redesign our logo, and maintain and adjust our marketing brochures. Being able to maintain our marketing collateral in-house has saved Cars for Keeps approximately \$3,000 in 2024."

Cory also attends many of the Douglas W. Eberle Series sessions. "The Eberle series has provided guidance and insight on how to structure and grow our board. We have added 4 members this year and attending Eberle sessions have helped identify clear roles and the launch of new committees," said Shively.

## **A Place to Preserve History**

The Tippecanoe County Historical Association (TCHA) purchased the Frank C. Arganbright Genealogy Center in 1977, fulfilling a need for more space for their ever-growing staff and collection. Currently, the Frank C. Arganbright Genealogy Center houses the Alameda McCollough Research Library, Richard B. Wetherill Archives, TCHA Administrative offices and collections storage. In addition to the

important roles it serves for TCHA, this building is one of the best commercial examples of the midcentury modern architecture style in the greater Lafayette community. Over the last 5 years, efforts have concentrated on the interior of the property. This year, TCHA began to shift to the exterior of the building. A grant they received from The Foundation this fall for \$43,640 aims to assist in those efforts.
